Welcome to the Simi Valley Kennel Club AKC Agility Trial. Please review the following information and contact the Trial Secretary, Larry Ribbeck, at lrubbeck91@gmail.com or (805) 433-5042 if you have any questions.

TRIAL SITE INFO: Directions to the trial location and the Emergency Veterinarian are enclosed. The park has quite a few trees, but it's a good idea to bring your own shade. Friday set up is no earlier than 10 am unless you are helping set up the rings and equipment. No spaces can be marked off and held for another exhibitor until after 10:00 a.m. even if you are helping with set up. This excludes spaces marked off and held by Jump City for judges and/or Jump City employees.

RV Overnight Parking: RV overnight parking (without hook ups) is available on a prepaid basis which can be done via the Jump City Agility web site: <http://www.jumpcityagility.com/enter.html>. **In addition to the payment, contact Cara Callaway (<mailto:fun4dogs@aol.com>) to secure a reservation.**

Food: Breakfast items will be provided for exhibitors. Lunches are provided for the workers. Lunches are not provided for half day trials on Friday. There are some fast food restaurants close to the park.

VMO: Neither Judge is a VMO so measurements are valid for this trial only.

Volunteers: Thank you so much to all of you who volunteered. If you have not volunteered to work and would like to, please email Kathy Kogen at kathyko@socal.rr.com or contact Kathy the day of the trial. If you work you'll get lunch and have a chance to earn Jump Bucks that may be used at future Jump City trials or at Jump City Agility classes.

Move-ups: All pre-show move ups must be received by 6 pm (PST), Monday before the trial. AKC requires move-ups to be in writing. You may send an email for a move-up to lrubbeck91@gmail.com with your name, your dog's call name, the name & date of the trial and what class you want the dog to be moved to. If you miss the deadline, you will need to follow the day-day move-up regulations.

Day-to-Day Move-Ups: The request for moving up must be made in writing at the trial site to the Trial Secretary not later than the day preceding the event provided the Trial Secretary receives them by the end of the trial day. Day-to-day move-ups **may not** be requested via the phone or by email. It is permissible for an exhibitor to request a day-to-day move-up in person for the following day on a trial day of which he/she did not show their dog. The exhibitor may have someone else on-site fill out/sign the form as their representative.

No dogs allowed in the restrooms. Please remember to clean up after your dog. All dogs must be kept on leash unless in the ring or at the warm-up jump.

Please listen for any announcements about a change in the run order or walk-throughs. Dogs may be run in a different height or dog order from that which was drawn when, in the opinion of the judge(s) and/or the Event Committee, such a change will result in a desirable and reasonable time savings. If necessary, walk-throughs may be added or combined if there are conflicts.

First dog on the line at noon- Armband labels are not used at this trial as AKC has dropped that requirement. The list of dogs that need to be measured will be posted along with the running order at the table where the course maps are. If a dog needs to be measured, it is solely the responsibility of the handler to be sure their dog is measured before their runs. Directions from Trial Site

- Head east on E. Pleasant Valley Rd for 7.4 miles
